Patrol License

Scope of Work:

The **Patrol License** supports frontline officers by automating routine tasks, reducing administrative burdens, and providing real-time guidance in the field. With tools that reinforce training, improve reporting accuracy, and recognize officer performance, TRULEO helps patrol officers stay focused on community engagement and public safety.

Core Features:

Virtual FTO (Field Training Officer)

An on-demand knowledge assistant that answers officer questions about policy, procedure, or best practice with cited answers directly from the department's documentation. Functions as a digital mentor, bridging training gaps and ensuring real-time compliance.

Automated Narratives

A conversational AI that helps officers draft complete, professional reports. Supports custom formatting, integrates audio transcripts from witnesses and victims, and acts like a virtual supervisor, providing suggestions to improve clarity and accuracy.

Automated Interviews

Allows officers to dial into TRULEO from their phone to record and transcribe witness interviews. With department approval, TRULEO can also conduct the interview itself, asking structured questions to ensure consistency and completeness.

Automated Dispatch

Enables officers to query their Records Management System (RMS) directly through TRULEO to retrieve and summarize information about vehicles, individuals, or addresses. Saves time and improves situational awareness in the field.



BWC Analysis & Redaction

Reviews body-worn camera (BWC) footage to highlight and praise officer performance — such as professionalism, de-escalation attempts, and handling noncompliance. Promotes a culture of recognition and coaching while automatically redacting sensitive information to protect privacy.

Command License

Scope of Work:

The **Command License** equips law enforcement leadership with the tools to improve accountability, identify risk, and optimize operations. By providing deep insights into agency performance and compliance, it enables command staff to make informed, data-driven decisions while ensuring policies and budgets remain aligned with community expectations.

Core Features:

Virtual Admin Analyst

Identifies policy and training gaps across the department, offering actionable recommendations to reduce risk and improve compliance. Acts as a digital advisor for proactive leadership.

Admin Reporting

Connects securely to the department's databases and files, generating custom reports across areas such as personnel performance, operational outcomes, and financial status.

CompStats

Integrates with the **RMS** to deliver detailed **crime trend and analysis reports**. Helps leadership identify hotspots, track performance metrics, and optimize resource deployment.

Policy & Compliance

Instantly generates and customizes department policies while producing proofs required for accreditation. Simplifies compliance and accreditation workflows, reducing administrative strain.

Budgeting

Provides tools to analyze financial data, generate Excel spreadsheets, and prepare reports for budgeting and fiscal oversight. Supports transparent and data-driven financial planning.

Scope of Work:

The **Investigations License** empowers detectives, analysts, and specialized units with advanced AI tools to strengthen cases, streamline reporting, and surface actionable intelligence. By automating routine documentation and enabling sophisticated data analysis, TRULEO helps investigators build stronger cases in less time.

Core Features:

• Virtual Crime Analyst

A digital investigative partner that answers case-related questions, recommends next steps, and can be tasked with cross-referencing databases or locating suspect information.

Automated Reports

Generates a wide variety of investigative documents, including case summaries, search warrants, arrest warrants, affidavits, and updates — all drafted automatically to legal standards.

• Case Query & Hardening

Strengthens cases by role-playing as a defense attorney, uncovering weaknesses in files, and simulating courtroom cross-examination. Helps officers close gaps and prepare confidently for trial.

Witness Canvassing

Integrates with mass text notification systems to generate a callback number for community tips. TRULEO can interview witnesses, transcribe conversations, and curate responses, allowing detectives to focus on the most promising leads.

• Intelligence

Provides advanced analysis of cell phone data and jail calls, integrating with tools like Cellebrite and Magnet. Capabilities include CSAM detection, conversation summarization, and pattern-of-life analysis. Also offers covert digital persona management for specialized investigative units such as ICAC.
